ORDER : (ORAL)

The writ petition is filed seeking to declare action of
respondent No.4 - Station House Officer, Lingampet Police Station

in calling the petitioner to the Police Station without any crime or G.D. entry, as illegal and arbitrary.

2. Learned Assistant Government Pleader for Home having received the written instructions dated 09.03.2023, submitted that petitioner is accused in Crime No.87 of 2022 registered for the offence punishable under Section 394 of the Indian Penal Code, 1860 (for short the 'IPC') of Lingampet Police Station, Kamareddy District and pending trial in C.C. No.170 of 2022 on the file of the learned Judicial First Class Magistrate Court, Yellareddy, Kamareddy District. Petitioner is also accused in Crime No.89 of 2022 of Gandhari Police Station, Kamareddy District and pending trial in C.C. No.232 of 2023 on the file of the learned Judicial First Class Magistrate Court, Yellareddy, Kamareddy District. Suspect sheet No.267 was opened against the petitioner at Gandhari Police Station and it was transferred to Lingampet Police Station on 11.07.2022 on the point of jurisdiction as the petitioner is residing within the limits of Lingampet Police Station. The petitioner was also detained under the provisions of the Preventive Detention Act in the year 2022. For the purpose of maintenance of suspect sheet against the petitioner herein and in order to ensure his appearance before the learned Judicial First Class Magistrate, Yellareddy, Kamareddy District in the above two cases, the petitioner was telephonically informed about the dates of his appearance before the Court below in the above two cases. Police did not interfere with personal liberty of the petitioner.

3. Recording the submissions of the learned Assistant Government Pleader for Home, this writ petition is disposed of as no further orders are required to be passed. If the petitioner is aggrieved by opening of suspect sheet, he is at liberty to invoke the same by appropriating legal remedy. A copy of the written instructions dated 09.03.2023 is served on the learned counsel for the petitioner. There shall be no order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in this writ petition shall stand closed.
