ORDER

Sri. Aditya Singh, learned Central Government Counsel accepts notice for respondents 1 to 6.

2. In this writ petition, the petitioner has challenged the order of transfer dated 02nd March, 2023 (Annexure-H) passed by the respondent No.4; inter-alia sought for direction to the respondent No.2 to consider the representation of the petitioner dated 12th May, 2023 (Annexure-N).

3. Heard Sri. Srinivasa K., learned counsel appearing for the petitioner and Sri. Aditya Singh, learned Central Government Counsel appearing for respondents.

4. Sri. Srinivasa K., learned counsel appearing for the petitioner contended that the impugned order of transfer made by the respondents is non-est on the ground that the order is premature in nature and further he contended the petitioner has made representation as per Annexure-J to the respondent- Authorities through proper channel, however, the same has not been considered.

5. Per contra, Sri. Aditya Singh, learned Central Government Counsel appearing for respondents, on WP NO.10388 OF 2023 instructions, submits that the petitioner has been relieved from the present post.

6. Having heard the learned counsel appearing for the parties and taking into account the factual aspects on record that, as the petitioner has made representation dated 12th May, 2023 (Annexure-N) to the respondent No.2, I am of the view that the respondent No.2 shall consider the same in accordance with law, within an outer limit of two weeks from today and communicate the outcome of the same to the petitioner at the earliest. Accordingly, writ petition is disposed of.

All contentions of the parties are kept open.
