Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction with more particularly in the nature of WRIT OF MANDAMUS declaring the action of the Respondent Authorities not initiating any action to stop illegal sale of Petroleum products within the State of Andhra Pradesh which are actually meant for sale and consumption in Yanam and consequently direct the full fledged enquiry by CBI or Special Investigation Team (SIT) to stop the illegal trade of Petroleum products across the borders of Andhra Pradesh and Yanam, and to prosecute the perpetrators of this illegal trade.

### IA NO: 2 OF 2023

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent Director General of Police, Andhra Pradesh and the Commissioner, Civil Supplies Department, State of Andhra Pradesh to forthwith set up Special Investigation Team (SIT) to curtail the sale and usage of such Petroleum products in AP which are actually meant for sale and use within the geographical boundaries of Yanam, Pending disposal of WP(PIL) 154 of 2023, on the file of the High Court.

## IA NO: 1 OF 2023

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent Petroleum Corporations not to take further steps pursuant to the notification dated 28-6-2023, Pending disposal of WP(PIL) 154 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri K.S.Murthy, Senior Counsel representing Sri Ponnada Sree Vyas, Advocate for the Petitioner, Sri Harinath N (Deputy Solicitor General of India) for the Respondent Nos. 1 & 2, Sri P.Venkata Rao, Standing Counsel for the respondent Nos. 3, 6, 7 & 11, Sri V.R.Reddy Kovvuri, Standing Counsel for the respondent Nos. 4, 5 & 10, Sri V.V.Satish, Standing Counsel for the respondent Nos.8, 9 & 12, GP for GAD for the respondent No.13, GP for Commercial Tax for the respondent No.14, GP for Home for the respondent No.15 and of GP for Civil Supplies for the respondent No.16, the Court made the following

#### ORDER:

"Heard Sri K.S.Murthy, learned Senior Counsel, representing Sri Ponnada Sree Vyas, learned counsel for the petitioner on record.

Challenge in the present Writ Petition is to the inaction on the part of the respondent authorities in initiating action to stop the illegal trade of Petroleum products within the State of Andhra Pradesh.

It is submitted by the learned Senior Counsel that as on date, there are ten(10) Petroleum Outlets within the limits of Yanam and once again by way of the impugned notification, the respondent Corporations are proposing to

establish '11' more Petroleum Outlets in Yanam and the population of Yanam is 69,375 only. It is further submitted by the learned Senior Counsel that as long back as on 04.05.2018, the State Level Co-ordinator addressed a letter *vide* reference Ref:SLC/AP/YANAM, expressing concern over the issue. But, despite the same, without remedying the said issue, once again by way of the impugned notification, '11' more outlets are proposed to be established in Yanam.

Learned Deputy Solicitor General for Union of India, Sri N.Harinath, and learned Government Pleader for Civil Supplies Department, State of Andhra Pradesh pray time for filing counter affidavit.

Having regard to the submissions of the learned Senior Counsel for the petitioner and taking into consideration, the averments made in the affidavit filed in support of the Writ Petition, there shall be a direction to the Respondent Petroleum Corporations not to finalize establishment of Petroleum Outlets pursuant to the impugned notification, dated 28.06.2023, pending further orders. However, other proceedings may go on.

Learned counsel for the petitioner is permitted to take out personal notice to the respondents by RPAD and file proof of service into the Registry.
